Summary

This report has been prepared pursuant to the Caltrans/FHWA Memorandum of Understanding (MOU) regarding State assumption of responsibilities under Section 6005(a) of the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU), codified as Section 327 of amended Chapter 3, Title 23, United States Code (23U.S.C. 327). MOU Section 8.2.7, monitoring and oversight, requires Caltrans to provide a report every 3 months to the FHWA California Division, listing any approvals and decisions Caltrans has made with respect to the responsibilities Caltrans has assumed under part 3 of the MOU. This report provides a list of all Section 6005 approvals from April 1 through June 30, 2008.

A total of two 6005 CEs were approved by Caltrans during the fourth quarter of the Pilot Program. Caltrans also approved five Environmental Assessments, five Findings of No Significant Impacts (FONSI), and one Draft Environmental Impact Statement during the reporting period. In addition to the environmental document approvals, four Notices of Intent (NOIs) and one Record of Decision (ROD) was signed.
