The amendment includes projects with funding from the State Highway Operation and Protection Program, Federal Earmarks, Highway Maintenance Program, Congestion Mitigation and Air Quality Improvement Program, Proposition 1B – Transportation Bond Program, Federal Transit Administration (FTA) 5307 and 5309 programs, and the American Recovery and Reinvestment Act of 2009.</li> </ul>

MTC has certified that the amendment is financially constrained, does not change air quality conformity, and meets the requirements of public involvement procedures adopted by MTC.

Pursuant to the authority delegated to me, I approve MTC's Amendment Number 30. I also recommend that the Federal Highway Administration and FTA approve this FTIP amendment for inclusion into California's 2009 Federal Statewide Transportation Improvement Program (FSTIP). Projects included in this FTIP amendment, in fiscal years not within the four-year cycle of the current FSTIP, are not approved as part of this FTIP amendment and are shown for information only. Approval of this amendment does not constitute an eligibility determination of projects for federal funding.
