The California Department of Transportation has completed the review of San Diego Association of Governments' (SANDAG) administrative modification number 6 to their 2008/09 – 2013/14 Federal Transportation Improvement Program (FTIP). SANDAG submitted this change consistent with the Federal Statewide Transportation Improvement Program (FSTIP) modification procedures. This change does not require Federal Highway Administration or Federal Transit Administration approval. Therefore, it has been incorporated into California's 2009 FSTIP.

This amendment modifies Caltrans State Highway Operation and Protection Program (SHOPP) lump sum swapping funds and using American Recovery and Reinvestment Act (ARRA) of 2009 funding for an Interstate 805 Southbound Auxiliary Lane between State Route 54 and E Street, in the City of Chula Vista. In addition, two Interstate-15 projects exchanged funds. See enclosed documentation.
