The California Department of Transportation (Caltrans) has completed the review of the following amendment to the Stanislaus Council of Governments (StanCOG) 2010/11-2013/14 Federal Transportation Improvement Program (FTIP):

The amendment modifies or adds projects from the StanCOG region. The amendment includes projects funded from the State Highway Operation and Protection Program, Safe Routes to School (SR2S) Program, Congestion Mitigation and Air Quality Improvement Program, and the Highway Bridge Program.

Approval of this amendment does not constitute an eligibility determination of projects for federal funding.
